## Read the following script as a PREAMBLE for conducting a Directed NET.

Attention all amateurs, attention all amateurs, this is (Call SIGN)\_\_\_\_\_\_, my name is (Name)\_\_\_\_\_, transmitting from (Location/City-State)\_\_\_\_\_\_, opening a DIRECTED NET for the (example) Grundy County Amateur Radio Club weekly net , or (example) Grundy County SKYWARN Weather Spotters.

"This is a directed net. Please direct all traffic through net control." "So firstly, is there any Emergency or Priority Traffic for the net?" [BREAK] (Say the word BREAK and un-key the transmitter to allow priority traffic to access the repeater)

### (The following text for Weekly Nets)

"This net is held each Monday of the Month at 19:00 Local Time on the KB9SZK 2 meter repeater located in Morris Illinois. The PL tone for this repeater is 107.2"

"The Grundy County Amateur Radio Club meets the 1st Tuesday of each month at the Grundy County Administration Building, located at 1320 Union St. Morris Illinois. Meetings begin at 1900 hours. All are invited to attend".

"The purpose of this net is to establish and maintain communications related to Amateur Radio for the Grundy County Amateur Radio Club. When you check in, please indicate your name, call sign phonetically, location and whether or not you have traffic and/or announcements and whether you are a member of the Grundy County Amateur Radio Club".

"I will now take check-ins. Please wait for net control to acknowledge each check in before the next check in."

Net control, repeat back the call, name, and location! Net control operator; please keep a list of check-in's; name, call, and location.

(For Weekly Nets) After all check-ins have been completed, first - call on stations with traffic. Announce any Club items of interest.

(For SKYWARN Weather Nets pass Advisory, Warnings, Watches, and information as needed and collect and Document pertinent event information to pass as traffic to the designated agency.)

### (At the end of the net)

"I am now closing the net at \_\_\_\_\_\_ (time). We had \_\_\_\_\_ number of check-in's. (For Event Directed Nets track the check-in/Locations and insure that all check-ins are checked out.)

### (For Weekly Nets)

The Grundy County Amateur Radio Club would like to thank all those that participated in this net. The next net will be Monday (Month) \_\_\_\_\_\_ (Day of the month 1-31) \_\_\_\_ at 19:00. The next club meeting will be Tuesday, (Month) \_\_\_\_\_ (Day of the month 1-31) \_\_\_\_ at 19:00. All are welcome to attend.

Once again the location is the Grundy County Administration Building located at 1320 Union St. Morris Illinois. Enter in door number 7 next to the overhead doors on the west side of the building; enter in off of School St.

#### (Closing the Net)

"Net Control now returns this Repeater back for normal amateur use."
